

- Electric energy, partly through hydroelectric power and photovoltaic, our own facility provides 280,000 kWh annually valid for HN.
- The coolers of lasers cooled by the outside air consume 25% less power compared with standard cooling
- The vehicle fleet of the company Marbach has cars with low fuel consumption, largely with BlueMotion Technology.
